3. The lease can be cancelled by Calgary Golf Car Centre without notice due to improper or illegal use of equipment.
4. The Lessee must ensure the leased equipment is operated in a safe manner at all times
5. Calgary Golf Car Centre does not provide insurance on the leased equipment. The Lessee shall reimburse Calgary Golf Car Centre for any loss incurred due to theft, vandalism or damage of any kind caused during the lease period. Damages to third party property by the leased equipment while in the control of the Lessee or its agents shall be the responsibility of the Lessee
6. Calgary Golf Car Centre, its officers and employees shall not be liable for any personal injury, loss of or damage to property resulting from the use of the leased equipment. The Lessee agrees to protect and indemnify Calgary Golf Car Centre, its officers and employees, against any liability for such injury resulting from the use of the leased equipment.
7. The Lessee shall make no adjustment or alterations to the leased equipment.
8. The Lessee is not entitled to a refund or compensation due to cancellation of the lease
9. In the event the leased equipment is non-operable, Calgary Golf Car Centre must be notified immediately and the equipment will be repaired or replaced as required.
10. The Lessee is not entitled to a refund or compensation for driver error which causes equipment failure rendering the equipment inoperable.
